After-dinner entertainment was provided by 'The Bank Manager', Mr. David Kendall, and the customary charity raffle raised £505 in aid of Demelza Children's Hospice in Sittingbourne. Many thanks to Alcohols and Hayman for generously donating prizes on the night.

SIA Training Course takes European Tour!



Following successful events in Manchester, Leeds and London, the SIA Training Course, 'An Introduction to the Solvents Industry', was rolled out to our colleagues in the European Solvents Industry Group (ESIG) in April and September when courses were held at the Cefic offices in Brussels.

The course is suitable for anyone within the industry who would like to acquire a greater understanding of solvents, or for those who are new to the industry and would like to learn more. Participants included sales

representatives, product managers and office-based employees of ESIG members, which consist purely of large solvent manufacturers.

The course is designed to complement the work previously carried out by the SIA and ESIG in the production of solvents safety DVDs and accompanying guidelines, and to increase understanding of the importance of the industry to the global economy. It covers the history of solvents, explains the different types and applications, illustrates their safe handling and regulatory aspects, as well as an introduction to Product Stewardship.

The training is an integral part of any solvents education programme, and aligns with our commitments to Responsible Care and Product Stewardship.

A third ESIG-sponsored course will be held in Rotterdam on April 12th and the next UK-based event will take place on 30th June in Stratford-Upon-Avon.
