# Webinar: Electrostatic charge and Discharge

On 25th March the SIA held an online event in collaboration with Elaflex to highlight the importance of hose and connection selection for certain applications.

Elaflex specialise in safe hose assemblies and connectors for safety critical applications and the objective of the presentation was to broaden awareness and technical knowledge about hoses. The safety aspects of transition hoses and hose assemblies is critical. The reliability of the assembly is therefore of special importance. Accidents have occurred through electrostatic discharge, the rupture of hoses or couplings that have simply blown off under pressure.

## **Guidance Notes**

The Technical Committee has been working very hard behind the scenes to bring our members 2 new Guidance Notes:

Guidance on Alcohol-Based Sanitisers

#### **Guidance Note 65 - Safe Handling and Use of Alcohol-based Sanitisers**





During the Covid-19 Pandemic of 2020-21, many countries saw a widespread increase in new entrants to the hygiene and sanitiser markets, some of which knew little of the Regulatory requirements of the handling, transportation, packaging and labelling of flammable liquids and, in many cases, the legislation surrounding dutiable ethanol.

This new Guidance Note attempts to assist companies in providing signposts to the appropriate legislation and guidance available, to prevent incident and potential injury from inappropriate handling.

#### **Guidance Note 66 - UK REACH Summary Document**

Following the UK's exit from the European Union on 1st January 2021, the UK Government has produced a wide range of documentation to support companies with the transition from EU REACH to UK REACH.

# **Legislation Update**

#### The National Chemical Emergency Centre

Emergency response | Regulatory compliance

The Dangerous Goods Emergency Action Codes (EAC) List 2021 is now available. The new list has again been produced by the NCEC, in co-operation with the UK Home Office and published by TSO.

The EAC List 2021 is effective immediately in connection with the use of ADR/RID 2021 Edition and is mandatory from 1 July 2021. The Emergency Action Code List 2019 should no longer be used from that date.

Duty holders are required to use the 2021 EAC List for the application of the appropriate EACs under Schedule 1 of the Carriage of Dangerous Goods and Use of Transportable Pressure Equipment Regulations 2009 (CDG 2009) (as amended); and of the Carriage of Dangerous Goods and Use of Transportable Pressure Equipment Regulations (Northern Ireland) 2010 (CDG 2010) (as amended).
