## Member Update – Dr Rob Oades

On April 28th SIA Technical Committee Chair, Dr. Rob Oades was awarded a long service award by the Royal Society of Chemistry (RSC) at their historic headquarters in Burlington House, Piccadilly, London.

Rob joined the RSC in 1982 as an Associate Member whilst studying Chemistry at The University of Hull. He became a Graduate of the RSC in 1983 and a full Member 6 years later, having completed his PhD and 3 years in industry. At this time, he also became a chartered chemist (C.Chem). For the next 22 years Rob worked in the Petrochemical Industry for BP Chemicals,



Ineos Nitriles and TOTAL Fluids in various research and technical roles. In July 2011 he was elected a Fellow of the RSC, the highest category of Membership, in recognition of his work as a chemist in industry - an achievement he is rightly very proud of, as it is rare for a chemist who has worked in industry only, to be designated C.Chem FRSC.

In the meantime, Rob has added Shell Product Stewardship to his extensive CV (since 2014) and has thus completed 40 years as a chemist.

The award was presented by Dr. David Small who presented the annual lecture - on the very interesting subject of cannabidiol and its use in medicine.

Rob was accompanied at the event by his wife Debbie, Rob said, 'Without the support of my wife and family, I would not have been able to achieve 40 years as a chemist. I am very proud and honoured to receive this award. Thank you.'

The SIA would like to congratulate Rob on this fantastic achievement and offer many thanks for his outstanding service to the Association over many years.

Hosted at their UK office in Stockport, BASF's Sustainability Manager, Tony Heslop, presented an engaging and thought-provoking one-day course, resulting in Carbon Literacy certification for the attending delegates, accredited by the Carbon Literacy Project.

What is Carbon Literacy?

'An awareness of the carbon costs and impacts

of everyday activities and the ability and motivation to reduce emissions, on an individual, community and organisational basis' The Carbon Literacy training course involves learning about greenhouse gases and their impacts, how the climate is changing and what that means for individuals and society. It then looks at the various choices that we all have in our everyday lives and how different choices may reduce the greenhouse gases we produce. At the end of the course, each participant commits to at least two impactful actions – one to reduce their personal carbon footprint and the other to help to reduce their organisation's carbon footprint.'

Andrew Norman, SIA Chief Executive said, 'The global chemical industry faces many challenges in the coming years to meet our environmental ambitions by 2050. However, the course also highlights the steps that we can all take as individuals to reach our collective net zero goals. I would thoroughly recommend the course to anyone'.



## **Technical Committee Update**

The Technical Committee of the Solvents Industry Association has updated and re-issued their **Guidance Note 60 – Safe Use and Handling of Hoses and Flexible Connections in the Solvents Industry**.

Utilising the expertise of Associate Members Elaflex and Manntek, along with solvents distributor Univar Solutions, the SIA has revised the Guidance to align with updated technologies and legislation. The original document was first issued in 2017.



The updated Guidance offers information on the appropriate types of hose and connections available, along with essential advice on maintenance and Risk Assessment.



In the UK, the 6th package of EU sanctions towards Russia has been published.


#### Publications Office (europa.eu)

The annex II contains 2 lists of substances that are impacted, which include several solvents and other chemicals. It also says on page 16, that the UK is a partner country in the implementation of these sanctions.

## **European Solvents Industry Group (ESIG)**

The ESIG Solvents Human Exposure Database has been updated with data from 2020 and 2021.

The updated version now contains data extracted from 331 publications and includes 3766 samples and 11990 measurement results. This makes the database the largest single source of solvent exposure data available to the industry and a broader audience.

## In Memoriam


It is with deep sadness to report that former SIA Chairman and General Secretary, Dr. Tom Farmer has passed away, aged 95.

Tom served as a Member of the Solvents Industry Association Board of Directors from November 1982 until 1985, serving as Chairman for 2 years in 1983-1984. Tom was employed by Carless, Capel & Leonard (now known as Haltermann Carless) as Technical Adviser for Solvents at the time.

Tom left the SIA Board in 1985 as, according to our records, he had changed his position within Carless so, presumably, he was no longer directly involved with solvents in his day-to-day role.

However, Tom returned to the SIA as General Secretary from the 1st April 1986, where he held the position until the 1st November 1996, where he then retired fully from the industry.

Everyone who knew Tom professionally, remembers him as a kind and gentle man, who was very well respected in the industry and was very helpful to everyone. The SIA would like to express our condolences to Tom's family and friends at this difficult time.



Dr Tom Farmer received the Eastlake Medal, last presented in 1988. He joined the IP in 1968 and later became a fellow. Seven years ago he received an Award of Council when he retired from the chairmanship of the London Branch. However, when problems subsequently occurred, he again became the branch's chairman and retired for the second time last year. During this time he also served as Chairman of the Branches Committee and as a most effective member of Council. He continues to be a member of both the Membership and Publications and Information Committees as well as playing an active role in many other facets of the Institute's work. He is the General Secretary, Solvents Industry Association.
